- Conclusion/Summary** : **Distillates (petroleum), hydrotreated heavy naphthenic**: Mineral oil mists derived from highly refined oils are reported to have low acute and sub-acute toxicities in animals. Effects from single and short-term repeated exposures to high concentrations of mineral oil mists well above applicable workplace exposure levels include lung inflammatory reaction, lipoid granuloma formation and lipoid pneumonia. In acute and sub-acute studies involving exposures to lower concentrations of mineral oil mists at or near current work place exposure levels produced no significant toxicological effects. **Natural graphite**: Laboratory studies have associated graphite with mild pulmonary fibrotic reactions when administered to rats by intratracheal injection. Numerous epidemiological studies performed in the mining, milling and carbon electrode manufacturing industries have associated a form of pneumoconiosis with overexposure to both synthetic and natural graphite. These data are not expected to be relevant to graphic used in a grease or oil matrix.
